**Sub:**-Telangana University- COVID-19 Virus – Certain instructions from Government of Telangana- Closure of Educational Institutions, Hostels & Messes – Lockdown measures till 31<sup>st</sup> July, 2020.

In continuation to the University Circular vide ref 2<sup>nd</sup> cited and in terms of the G.O. Ms. No. 93 of the General Administration (COVID) Department, Govt. of Telangana, read with the orders issued by the Government of Telangana all the COVID-19 control related orders issued vide Ref. 1<sup>st</sup> and 2<sup>nd</sup> cited, it is decided that lockdown measures shall be continued till 31<sup>st</sup> July, 2020. During the said period, all the University Colleges/Govt./Aided/Private under the jurisdiction of Telangana University including Libraries, Hostels and Messes will remain closed till 31.07.2020 to prevent and contain the spread of COVID-19 virus in the State of Telangana.

In the circumstances, all the Principals of University Colleges/Govt./Aided/Pvt. under Jurisdiction of Telangana University shall follow the said instructions and lockdown measures till 31.07.2020. Further, the Principals of the respective Institutions are hereby informed to take necessary action and submit a compliance report.

Therefore, you are instructed to adhere to the guidelines scrupulously in order to prevent the spread of COVID-19.

#### ORDER

In reference  $1^{st}$  read above, orders were issued prescribing measures to contain COVID-19 in the State of Telangana for the period up to  $30^{th}$  June 2020.

- 2. In reference  $2^{nd}$  read above, MHA has issued orders for extension of lockdown in Containment Zones till  $31^{st}$  July 2020 along with reopening of activities in a calibrated manner in areas outside Containment Zones.
- 3. The matter has been examined. It is decided that orders issued in reference 1<sup>st</sup> read above shall stand extended till 31<sup>st</sup> July 2020 in the State of Telangana with the following modification:

Movement of persons (other than for accessing emergency medical care) shall remain strictly prohibited from 10 PM to 5 AM.

However, movement of persons for operation of industrial units in multiple shifts, movement of persons on National and State Highways, loading and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and airplanes shall be permitted during this period.

No shops / establishments, except hospitals and pharmacies, will remain open after  $9.30\ PM$ .

In exercise of powers conferred under the Disaster Management Act 2005, the undersigned, in his capacity as Chairperson, State Executive Committee hereby issues directions to all Departments of Government of Telangana, Collectors & District Magistrates and Commissioners/Superintendents of Police in the State to strictly implement the above orders with immediate effect.
